The Board of Trustees of Miami Township, Clermont County, Ohio met in regular session at the Miami Township Civic Center on March 4, 2024, with the following members present: Mark Schulte, Ken Tracy and Mary Makley Wolff.

WHEREAS, Miami Township, Clermont County, Ohio (the "Township") advertised for bids to mow Evergreen, Mulberry and Union cemeteries and believes that the bid submitted by Brian Christian Landscaping is the lowest and best bid; and

WHEREAS, The Township seeks to enter into an agreement with Brian Christian Landscaping in the amount of \$40,012.00 to mow the Township's cemeteries.

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of Miami Township, Clermont County, Ohio as follows:

SECTION 1: The Board finds that the bid submitted by Brian Christian Landscaping in the amount of \$40,012.00 related to the mowing of Evergreen, Mulberry and Union cemeteries is determined to be the lowest and best bid.

SECTION 2: Interim Administrator is hereby authorized to execute an agreement with Brian Christian Landscaping in the amount of \$40,012.00 on behalf of the Board of Trustees of Miami Township, Clermont County, Ohio (the "Agreement"). A copy of the Agreement is attached as Exhibit A and incorporated herein by reference.

SECTION 3: The Board does hereby dispense with the requirement that this Resolution be read on two separate days, pursuant to Section 504.10 of the Ohio Revised Code, and authorizes the adoption of this Resolution upon its first reading.

SECTION 4: That this Board hereby finds and determines that all formal actions relative

to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.
