WHEREAS, Section 505.10(7) of the Ohio Revised Code permits the Board of Township Trustees ("Board") to dispose of unneeded, obsolete or unfit personal property which it determines to no longer be necessary for township use

WHEREAS, the property was advertised via public auction and no bids were received

WHEREAS, the Board has unneeded or obsolescent personal property no longer necessary for township use and shall destroy the property in Exhibit A

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Miami Township, Clermont County, Ohio by authority of Section 505.10(D) of the Ohio Revised Code, as follows:

- **SECTION 1**: The Board determines that the surplus equipment listed on Exhibit A is no longer of value and service to Miami Township.
- SECTION 2: That the property received no bids at internet auction or is unable to be fixed
- **SECTION 3:** The Board does hereby dispense with the requirement that this Resolution be read on two separate days, pursuant to Section 504.10 of the Ohio Revised Code, and authorizes the adoption of this Resolution upon its first reading.
- **SECTION 4**: That this Board hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5: This Resolution shall take effect at the earliest period allowed by law.
